

REPORT ON THE MRS. JAMES TREADAWAY TRACT No. 98.

- Location of Tract:** This tract is located on Mingus Creek, a tributary of Ocona Lufly River, flowing into the river at Ravensford. It adjoins the lands of the Champion Fibre Company, about 4½ miles from the mouth of the creek.
- Description of Tract:** This tract has been used for a home place and is a poor mountain farm most of which has been abandoned; although the owner is still living on it.
- Improvements:** A poor two-room box house several years old. Fields all abandoned and fences down. Slopes of hillside are steep and just a little flat land bordering the creek.
- Valuation:** This tract contains 41.56 acres and values are analyzed as below:

41 acre± land	400.00

The appraisers feel that this is all the place is worth and recommend the above price as called for in the option.

However, in the conveying clause and elsewhere is the ordinary fee simple deed. Some question has been raised as to this one-half mineral interest. But I am of the opinion that this is not sufficient to constitute this an exception.
