REPORT OF TRACT NO. 126 - GEORGE JENKINS
94.55 acres.

Location: This tract is located on Deep Creek, about four and one-half miles above its mouth. A public road passing through the tract. The creek also runs through the tract. It adjoins the lands of Champion Fibre Co. and other small property owners on Deep Creek.

Description: This is home tract occupied and farmed by the owner, there being fourteen acres of creek bottom, which is well tended and productive. The woodland has been cut over, but there is still a large amount of young growth on the property. If fishing rights are worth anything this is one of the tracts that would be desirable. However, these rights have not been taken into consideration in valuing the property.

Improvements: A 7 room framed house, two stories but only the lower story finished. The house is not in very good repair. There is also an old log house and two log barns in poor repair. A considerable portion of the property is fenced with two strands of wire.

Analysis of Title

Tract No. 126.

George Jenkins

1. Tract No. 126 now belonging to George W. Jenkins is included within the boundaries of a large grant from the State to Love, Battle and Welch. This Grant is fully referred to and set out on page 46 of the Abstract of Tract 172.

2. There is no connected chain of title from the State. The first reference we have found of record to this tract is contained in a deed from W. L. Hilliard, et al, the heirs at law of Robert Love, J. R. Love and R. V. Welch to Clarke Whittier. This deed is dated December 20, 1885, and will be found set out in full on page 57 of the Abstract of Tract 172. It contained a large number of exceptions referred to as "tracts of land alleged to have been granted by the State of North Carolina to the parties whose names are annexed to these exceptions or to those under whom they claim, before title to the said above described boundary of land accrued to us or our ancestors". Exception No. 40 in this deed refers to a tract belonging to J. P. Shuler and describing by metes and bounds a tract of 150 acres lying on Deep Creek, the description being identical in subsequent deeds for what is known as the "Corn Tassel Tract".

3. The next deed of record is a deed from James Terrell and Thomas D. Johnson, Attorneys for W. H. Thomas to George Shuler dated November 23, 1880, for this tract of land. This deed is set out in the Abstract of Tract 149 at page 1212.

4. George Shuler and wife, Margaret Shuler, then conveyed this tract to W. P. Shuler by deed dated February 25, 1884. This deed is also set out in Abstract of Tract 149 at page 1213.

5. W. P. Shuler and wife, Narcissus Shuler, then conveyed to George W. Jenkins by deed dated December 16, 1896, the same 100 acre tract. This deed is fully set out in Abstract of Tract No. 149 at page 1216.

6. On December 13, 1922, George W. Jenkins and wife, Cora L. Jenkins, executed a deed for a right of way to the Champion Fibre Company. This deed provides for a right of way thirty feet in width running on the east side of Deep Creek over and across the lands of George Jenkins, in the rear and at a distance of at least fifteen yards from his residence and the line of Adam Wheeler. This right of way is to extend for twenty years from and after its date with right to renew for another twenty years. This deed is recorded in Swain County and is set out in the Abstract of Tract 149 at page 1231.

George W. Jenkins, the present owner is now living upon said property and has had it under cultivation since his purchase thereof on December 16, 1896. At that time there had been possession under former owners and we think there can be no doubt as to the sufficiency of his title.
