

Analysis of Title

Tract No. 167--Hardy Clark

1. This tract of land is covered by the following grants: 685, 686, 121 and 998.

GRANT NO. 998.

2. Grant No. 998 was issued to James H. Wiggins on December 12, 1870. This grant is registered in Swain County. See page 503, Book 4.
3. On October 5, 1878, James H. Wiggins conveyed to Thomas A. Wiggins a portion of Grant 998, which covers the southern portion of Tract 167. This deed is recorded in Swain County. See page 504, book 4.
4. Thomas A. Wiggins and wife, Nancy L. J. Wiggins, by deed dated May 5, 1879, conveyed two tracts of land to Jane L. Kitchen. The second tract in this deed covers that portion of Grant 998 embraced within Tract 167. This deed is also referred to in paragraph 13 of this abstract.

GRANT NO. 685.

5. State Grant No. 685 was issued to John A. Millsaps, December 29, 1860, and is said to contain three hundred acres. This grant is of record in Jackson County. See page 92 of this abstract.
6. On October 21, 1872, John A. Millsaps executed his last will and testament, which was duly probated in the Clerk's Office of Swain County in Will Book 1, page 14. In this Will, E. Everett is appointed executor with power to sell land. See page 93 of this abstract.
7. On January 26, 1880, E. Everett as Executor of John A. Millsaps conveyed to W. L. Morris a tract of land containing 290 acres which is a portion of State Grant 685. This deed is of record in Swain County. See page 94 of this abstract.
8. On December 2, 1882, W. L. Morris and wife conveyed to W. H. Clark a tract containing seventy-six and one-half acres, which is a portion of the land described in the deed mentioned in the preceding paragraph. This deed is of record in Swain County. See page 95 of this Abstract.

9. State Grant No. 656 was issued to Samuel Amburn, January 16, 1845, and is said to contain one hundred acres. This Grant is of record in Jackson County. See page 96 of this abstract. So far as we have been able to determine from the records, Samuel Amburn never made a conveyance of Grant No. 656.
10. The next trace that we have been able to find of State Grant No. 656 is in a deed of conveyance dated October 23, 1854, from Mercy Campbell to James H. Wiggins. This deed is of record in Jackson County. See page 97 of this abstract.
11. On June 2, 1876, James H. Wiggins conveyed to Thomas A. Wiggins a tract of land containing twenty-five acres, which is a portion of State Grant No. 656. This deed is of record in Swain County. See page 98 of this abstract.
12. On May 5, 1879, Thomas A. Wiggins conveyed two tracts of land containing in the aggregate 130 acres to Jane Kitchen. This deed reserves one-fourth acre at the graveyard and says that W. L. Kitchen is to have a life estate in said land. We have been unable to determine from what source Thomas A. Wiggins derived title for a portion of the land described in this deed as we have been unable to find from the records any conveyance to him covering part of this land. This deed is of record in Swain County. See page 99 of this abstract.
13. On May 1, 1888, W. L. Kitchen and wife, Jane Kitchen, conveyed to J. C. Rogers a tract of land containing 154 acres. This deed includes a portion of the land mentioned in the preceding paragraph of this abstract; and also includes some land adjoining that we have been unable to find conveyed to either W. L. Kitchen or his wife, Jane Kitchen, and are unable to state where these parties acquired their title.
14. On June 14, 1885, J. C. Rogers and wife conveyed two tracts of land to W. H. Clark. This deed is of record in Swain County. See page 101 of this abstract.
15. On February 18, 1893, J. C. Rogers and wife, conveyed to W. H. Clark a tract of land containing 111 acres. This deed is of record in Swain County. See page 102 of this abstract.
16. On December 1, 1882, W. L. Kitchen and wife, Jane, conveyed a tract of land containing forty acres to W. H. Clark. This deed is of record in Swain County. See page 103 of this abstract.

The above conveyances to W. H. Clark compose what is known as the "W. H. Clark Homestead Land" situated on Deep Creek and estimated to contain about 240 acres.

Thereafter W. H. Clark died, intestate without conveying the above land and left surviving him the heirs set out in the affidavit on page \_\_\_\_\_ of this abstract.

17. The following conveyances are from the heirs at law of W. H. Clark to Hardy Clark conveying their interest in Tract No. 167, which said tract is a portion of the W. H. Clark lands.

(a) On August 10, 1915, M. A. Clark as Guardian of Thomas and Ernest Clark conveyed a two-eighths undivided interest in Tract No. 167 to Hardy Clark. This deed is of record in Swain County. See page 104 of this abstract.

The records in the Clerk's Office of Swain County show that on the 16th day of May, 1915, M. A. Clark was appointed Guardian for Thomas Clark and Ernest Clark, sons of Franklin Clark; but the records do not disclose that said guardian filed a petition asking for the sale to be made of these lands, nor is there an order authorizing her to make this sale. The qualification for Guardianship will be seen by reference to page 106 of this abstract.

(b) On June 25, 1925, M. A. Clark, widow, conveyed to D. H. Clark all her interest in Tract No. 167. This deed is of record in Swain County. See page 107 of this abstract.

(c) On May 15, 1909, Mary E. Sherrill and husband conveyed to D. H. Clark all their interest in Tract No. 167. This deed is of record in Swain County. See page 109 of this Abstract.

(d) On October 20, 1915, Annie Cagle and husband conveyed to D. H. Clark all their interest in Tract No. 167. This deed is of record in Swain County. See page 110 of this abstract.

(e) On September 14, 1910, D. L. Clark and wife conveyed to M. M. Clark a one-eighth interest in the W. H. Clark lands. This deed is of record in Swain County. See page 111 of this abstract.

(f) On May 25, 1916, M. M. Clark and wife conveyed to D. H. Clark a one-fourth interest in the W. H. Clark lands. This deed is of record in Swain County. See page 112 of this abstract.

(g) On July 30, 1925, M. M. Clark and wife, Lillie B., D. L. Clark and wife, N. L. Clark, T. L. Clark and wife, Laura Clark conveyed to D. H. Clark all their interest in the W. H. Clark lands. In this deed Lillie B. Clark failed to sign and acknowledge. However, her name appears in the preamble. This deed is of record in Swain County. See page 113 of this abstract.

18. After purchasing the W. H. Clark lands, D. H. Clark purchased a four acre tract located on the western boundary of the W. H. Clark lands and adjoining same. The chain of title of this tract is as follows:

19. State Grant No. 121 was issued to W. P. Hyde on October 13, 1880. This grant is of record in Swain County. See page 114 of this abstract.
20. On June 11, 1884, W. P. Hyde and wife, S. E. Hyde, conveyed to A. J. Cline a tract of land containing seventy acres, which portion embraces the locus in quo. This deed is of record in Swain County. See page 115 of this abstract.
21. On June 25, 1907, A. J. Cline conveyed to Amanda Cline two tracts of land which embrace the locus in quo. This deed is of record in Swain County. See page 116 of this abstract.
22. On July 12, 1888, A. J. Cline made his wife, Amanda, a free dealer. See page 117 of this Abstract.
23. On May 1, 1909, Amanda Cline, a free dealer, conveyed to Nathaniel Cline a tract of land containing twenty-five acres, which tract embraces the locus in quo. This deed is of record in Swain County. See page 118 of this Abstract.
24. On May 22, 1915, N. A. Cline and wife conveyed to D. H. Clark a tract of land containing four acres which is the locus in quo. This deed is of record in Swain Co. See page 119 of this abstract.
25. There are several deed in trust effecting tract No. 167 that have been canceled of record, which may be seen by reference to pages 120 to 126 of this abstract.
26. A Deed in Trust, dated May 25, 1887 from W. H. Clark to Clarke Whittier, given to secure the sum of \$20.00 recorded in deed in trust Book 1, page 132 has never been canceled of record. However, we are of the opinion that this instrument is barred by the statute of limitations. See page 127 of this abstract.
27. A Deed in Trust dated August 28, 1925, from D. H. Clark to Federal Land Bank of Columbia, given to secure the sum of \$2,000.00 due and payable thirty-four years after date. See page 128 of this abstract.
