REPORT ON THE JAMES T. KEENER TRACT - NO. .

Location: This tract is located on the waters of Coopers Creek adjoining the lands of the Champion Fibre Company. There is no number or map of this tract, it having been omitted from the survey, but it is so located that it rounds out the lower line of the Park boundary on Coopers Creek. Coopers Creek runs into the Tuckaseegee River at Ela, N. C.

Description: This tract has been used for a home place by the owner and there is a good small orchard. Otherwise, the farm is not very well cultivated.

Improvements: The house is six room, frame building, ceiled and weatherboarded, unpainted, and in rather poor repair, although it could be put in good shape without much expense. The other buildings are poor. This tract contains 30 acres, two-thirds of which is in woodland.

Valuation: The values are analyzed as follows:

The price agreed upon for this land is \$800.00. Its tax valuation is \$700.00. At the price agreed on, it would be a satisfactory purchase.

1. Tract No. 168 is embraced by State Grant No. 587 issued by the State to Love, Battle and Welch. This Grant is of record in Swain County. See page 46 of the Abstract of Title or Tract No. 172.

2. The next instrument that we have been able to find that effects the locus in quo is a deed from W. L. Hilliard, S. L. Love, Executors of J. R. Love and R. V. Welch by E. Everett, Agent, to Samantha Wiggins. The power of attorney authorizing E. Everett to make this conveyance may be seen by reference to page 46 of this Abstract. However, there would still be a one-third undivided interest in this tract outstanding in the heirs at law of Robert G.A. Love, as he purchased about the year 1871 all the interest of W. W. Battle in Grant No. 587. In this conveyance 2/3 of the mineral interest is excepted. See page 135 of this Abstract.

3. On July 28, 1882, Samantha Wiggins and husband J. J. Wiggins conveyed this tract of land to W. P. Hyde. This deed also excepts two-thirds of the minerals in the lands therein described. This deed is of record in Swain County. See page 136 of this Abstract.

4. On July 29, 1882, W. P. Hyde and wife, S. E. Hyde, conveyed the same tract to John J. Wiggins. This deed is of record in Swain County. See page 137 of this Abstract.

5. On February 10, 1885, John J. Wiggins and wife, S. L. Wiggins, conveyed to Thomas A. Wiggins a tract of land containing seventy-five acres, more or less, which is the same tract of land mentioned in the preceding paragraph of this analysis. This deed also excepts two-thirds of the mineral interests. This deed is of record in Swain County. See page 138 of this Abstract.

6. Thereafter, Thomas A. Wiggins died intestate leaving surviving him the heirs at law set out in an affidavit on page 139 of this Abstract.

The following conveyances are from the heirs at law of Thomas A. Wiggins conveying their interests in the Thomas A. Wiggins home tract, which tract embraces the locus in quo.

(a) On August 15, 1898, J. D. Wiggins and wife, S. J. Wiggins, Andy Wiggins and wife, S. E. Wiggins, J. W. Thompson and wife, S. L. Thompson, T. D. Watson and wife, M. E. Watson, conveyed to J. T. Koener a tract of land containing seventy-five acres, more or less, which is the tract known as the T. A. Wiggins home place. This deed is of record in Swain County. See page 140 of this Abstract.

(b) On March 9, 1901, M. A. Wiggins and wife, Mary Wiggins, conveyed to S. L. Thompson a one-seventh undivided interest in the tract of land known as the T. A. Wiggins place. This deed is of record in Swain County. See page 141 of this Abstract.

(c) On October 1, 1906, S. L. Thompson and husband conveyed to James Keener a one-seventh undivided interest in the Thomas Wiggins lands. This deed is of record in Swain County. See page 142 of this Abstract.

7. By referring to the affidavits of the heirs of Thomas W. Wiggins page 137 of this Abstract, it will be found that Julia R. Wiggins married J. T. Keener, and thereafter died leaving surviving her as heirs at law Elbert Keener and Jack Keener; as she never conveyed her interest in the Thomas A. Wiggins home tract, this leaves a one-seventh undivided interest outstanding which is owned by Jack Keener and Elbert Keener.

8. After the death of Julia R. Keener, J. T. Keener married Joannah H. Wiggins, who later died and left surviving her the following heirs at law:

1 Thomas Keener
2 Emma Keener
3 Nancy Keener
4 Pendleton Keener

5 Mary Keener
6 Sallie Keener
7 Susan Keener
8 John Keener

The last five being minors, and as Joannah H. Keener never signed away her interest in the Thomas A. Wiggins place, this leaves a one-seventh undivided interest outstanding in her heirs at law as above named.

9. On October 10, 1906, James Keener and wife, J. H. Keener executed to J. D. Wiggins a Deed of Trust given to secure the sum of \$40.00 on a one-seventh undivided interest on Thomas A. Wiggins place. This Deed of Trust has never been cancelled of record. However, we are of the opinion that since more than fifteen years have elapsed since maturity date, the said Deed of Trust would be barred by the statute of limitations.

10. On October 16, 1923, J. T. Keener executed to W. M. Taylor, Trustee, a Deed of Trust embracing tract No. 188 given to secure the sum of \$31.50. This deed of trust has never been cancelled of record. See page 144 of this Abstract.

11. On the 5th day of November, 1929, J. T. Keener was appointed Guardian for Emma Keener, Sallie Keener, Nancy Keener, Susan Keener, Pendleton Keener and John Keener, minor children of J. T. Keener and Joanna Keener, Joanna, now deceased, by J. T. Gribble, Clerk of the Superior Court of Jackson County. A transcript of which is registered in Swain County, see pages 142-a, 142-b and 142-c of this abstract.
